# Create a New Loan or Open an Existing Loan

### From the Loan tab within Encompass

- 1. Locate the Services tab on the left side of the screen. Then, select Order Title & Closing from the list.
- 2. A new window titled Order & Title Closing will open.
- Under the My Title Companies tab, select Radian Title Services. Then, click the Order button to proceed to the Radian Title Services Order Information page.

# Get a Title Quote & Post Fees

### From the Order Information page

- Select the Product/Service type from the drop-down menu located under ORDER DETAILS.
- 2. Click the Get Quote button.
- The Additional Information window will prompt you to answer a transactionspecific recording Question and add any Additional Documents to be recorded.
- If Additional Documents are selected for recording, you will have the option to specify page counts. Click the Next button to continue.
- 5. The Endorsements window will appear that allows you to select the available endorsements by state. Standard endorsements are preselected and can be deselected as necessary. Click the Get Quote to generate a PDF quote document that you can save.
