Radian Announces Origination and Servicing Guide Changes

The following are highlights of upcoming updates to Radian's Origination and Servicing Guide (Master Policy #RAF 483), Legacy Origination and Servicing Guide (Master Policy #RAF 1040), and Legacy Default and Claims Servicing Guide (Master Policy #RAF 1040), effective March 25, 2019. A complete list of enhancements will be available under the Revision Notes located within each Guide.

Origination and Servicing Guide (Master Policy #RAF 483)

- Submit a Loan modification report (Section 3.11, B.)
 This section will be updated to include new Loan modification report submission procedures.
- Modification programs (Section 5.2)
 This section will be updated to include references to the new Fannie Mae High Loan-to-Value Refinance Option and Freddie Mac Enhanced Relief Refinance[®] Initiatives.

Legacy Origination and Servicing Guide (Master Policy #RAF 1040)

- Loan modifications (Section 3.5)
 - This section will be restructured to include:
 - The Homeowner Affordability and Stability Plan (HASP) and Home Affordable Refinance Program (HARP) expiration dates;
 - New Loan modification report submission procedures; and
 - o Removal of the Home Affordable Modification Program (HAMP) table.

Legacy Default & Claims Servicing Guide (Master Policy #RAF 1040)

• Forbearance plans (Section 5.1, C.)

The final sentence in this section has been updated to "Forbearance arrangements should be formal and agreed upon between the Servicer and Borrower."

Origination and Servicing Guide (Master Policy #RAF 483) and Legacy Default & Claims Servicing Guide (Master Policy #RAF 1040)

- Non-performing Loan modifications (Origination and Servicing Guide Section 13.3 and Legacy Default and Claims Servicing Guide Section 5.1, D.)
 The coverage terms within the non-performing Loan modifications table will be updated due to recent changes in Radian's GSE and non-GSE modification policies.
- Notification of Mortgage Insurance Modification (Origination and Servicing Guide Appendix A and Legacy Default and Claims Servicing Guide Appendix A.)
 The appendix will be updated to include new website and excel Notification of Mortgage Insurance modification forms.
- Document requests associated with perfecting a Claim (Origination and Servicing Guide Section 15.1, A. and Legacy Default and Claims Servicing Guide Section 8.1.)
 This section will be updated to a standardized form and align timelines with the applicable Master Policy.
