#### Radian Announces Origination and Servicing Guide Changes

The following are highlights of upcoming updates to Radian's Origination and Servicing Guide (Master Policy #RAF 483), Legacy Origination and Servicing Guide (Master Policy #RAF 1040), and Legacy Default and Claims Servicing Guide (Master Policy #RAF 1040), effective July 1, 2019. A complete list of enhancements will be available under the Revision Notes located within each Guide.

## Origination and Servicing Guide (Master Policy #RAF 483) and Legacy Origination and Servicing Guide (Master Policy #RAF 1040)

- E-Bill Statement of Renewal Premiums Due (Origination and Servicing Guide Appendix A and Legacy Origination and Servicing Guide Appendix A)

  The appendices will be updated to reflect the new E-Bill Statement of Renewal Premiums Due form.
- Post-Commitment Data Changes/Changes to Certificates (Origination and Servicing Guide Sections 4.3, B. and Section 5 and Legacy Origination and Servicing Guide Sections 2.7, A. and Section 3.3) These sections will be updated to clarify that Radian only accepts Loan attribute change requests to a Commitment or Certificate from the Servicer in Radian's records.
- Methods for Paying Renewal Premiums & Methods for Remittance File Delivery (Originations and Servicing Guide Sections 7.5 & 7.6) and Renewal Premium Billing and Payment, Methods for Paying Renewal Premiums, & Methods for Remittance File Delivery (Legacy Origination and Servicing Guide Sections 3.11, 3.11, A., & 3.11 B) These sections will be updated to remove references to paper billing.

# Origination and Servicing Guide (Master Policy #RAF 483) and Legacy Default & Claims Servicing Guide (Master Policy #RAF 1040)

- The Claim Liability Calculation (Origination and Servicing Guide Section 17 and Legacy Default and Claims Servicing Guide Section 10.3) These sections will be updated as per the applicable Master Policy to add detail regarding the Claim liability calculation steps.
- Review Types and Document Requirements (Origination and Servicing Guide Appendix D and Legacy Default and Claims Servicing Guide Section 8.1, A.) These sections will be updated to include "Mortgage/Deed of Trust" and replace "442 completion certification" with "Appraisal Update and/or Certificate of Completion (1004D/442)" as required documents.
